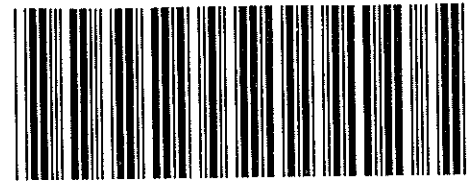

**SECOND AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS,  
RESTRICTIONS FOR SIENNA ESTATES HOMEOWNERS ASSOCIATION**

THIS SECOND AMENDMENT TO DECLARATION OF COVENANTS,  
CONDITIONS, RESTRICTIONS (this "Amendment") is made as of the 1st day of January,  
2007, by Cornerstone Sienna Estates, LLC, an Arizona limited liability company ("Declarant").

RECITALS

A. Declarant is the Declarant under that certain Declaration of Covenants,  
Conditions, Restrictions and Easements for Sienna Estates Homeowners Association, dated  
August 23, 2006 and recorded on August 25, 2006, as Instrument No. 2006-1131249, Official  
Records of Maricopa County, Arizona, and as Amended in the Amendment to Declaration of  
Covenants, Conditions, Restrictions For Sienna Estate Homeowners Association, dated and  
recorded on September 7, 2006, as Instrument No. 2006-1192632, Official Records of Maricopa  
County, Arizona (the "Declaration"). Capitalized terms used and not otherwise defined herein  
shall have the meanings set forth in the Declaration.

B. Declarant, as owner of not less than seventy-five percent (75%) of the Lots within  
Sienna Estates, desires and intends to amend the Declarant as set forth in this Amendment.

AGREEMENT

NOW, THEREFORE, the Declarant is hereby amended as follows:

1. Exhibit B attached to the original Declaration, is hereby replaced by the attached  
Exhibit "B."
2. Article 4, Section 4.5 is hereby deleted in its entirety as well as all specific references  
to Section 4.5 in the Declaration.
3. Except as specifically amended hereby, all of the terms of the Declaration shall  
remain in full force and effect.

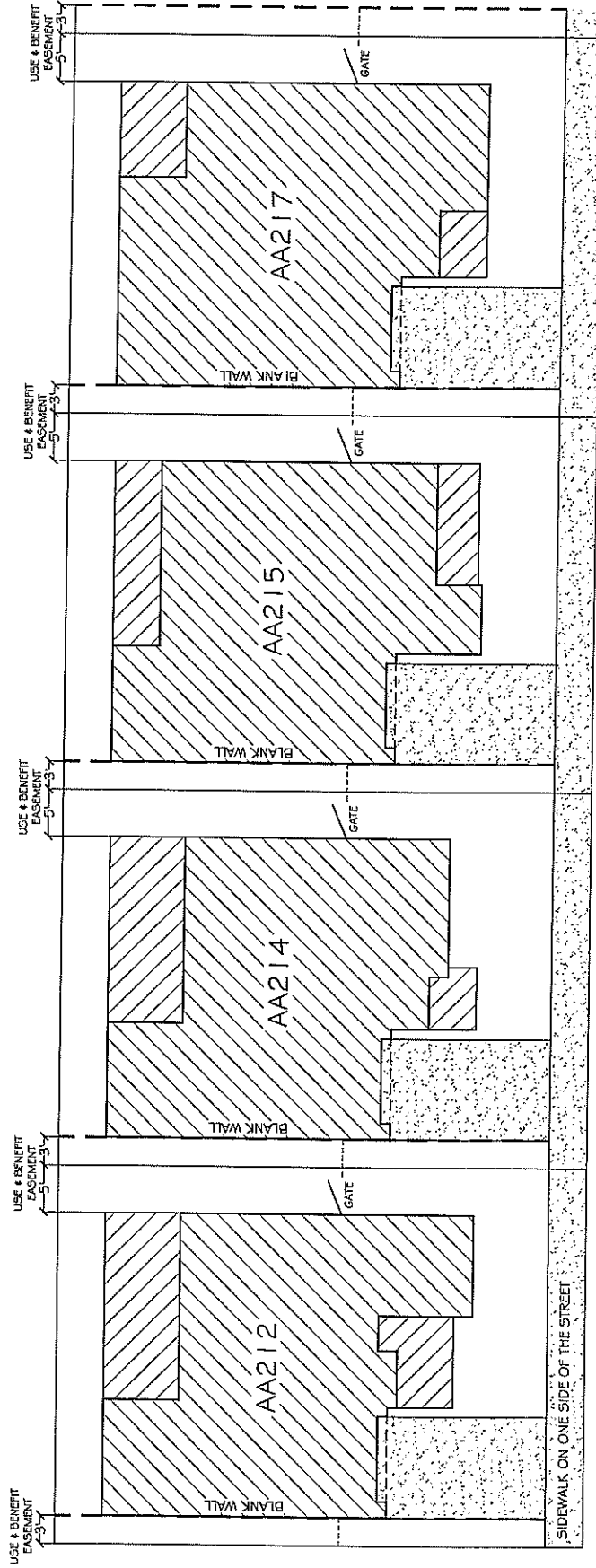
