### **Pool Update**

The Special Assessment of \$400 did not pass and the Board has decided to not try for a re-vote. There are issues that need to be addressed with the pool. The pool fence is in need of replacement, a taller one is being installed to keep unwanted persons out. There will still be a new spa built in the grass area next to the bathroom. The new spa will be 8 X 12 and netting will be installed around the fence to prevent debris from blowing in as well as privacy from the road. A camera system will also be

installed. With the camera and key fob system it is expected to decrease vandalism of the Communities property, and if any should occur assist in finding the responsible party.

## **Exterior Home Changes**

For any changes to the exterior of your home you must submit an architectural request form for review by the Architectural Committee. This form is available on the Sienna Estates website (siennaestates.homestead.com) under the "forms" tab on the left hand side.



### **Parking Reminder**

Parking decals are required to be on the lower left hand side of the windshield if your car is parking on the street overnight. Also remember to utilize your garage and driveway first, if you have a car parked on the street and your driveway is empty then your car will be towed. ### Security

We have a new Security Company working for Sienna Estates. SecureOne Security Services, if you would like to report a security issue you may go to www.patrol.com, go to the drop down menu then report an issue and click on security.

SecureOne will be patrolling random times and will be checking for parking violations between the hours of midnight and 6A.M. just as the previous company did. Remember to use the reporting site for security issues only, dial 911 for emergency.

The tow company remains the same as before, if you need to retrieve your vehicle the number is the same.
